38. Finlay Park Development Opportunity

Council is informed that Whitewater Holdings, LLC, a firm located in Charlotte, NC, provided the sole response to the Request for Proposals for the Finlay Park Development Opportunity issued on October 5, 2018.

Council is asked to authorize the City Manager to collaborate with Whitewater Holdings, LLC to create a comprehensive conceptual design for the Finlay Park Development Opportunity.

Next steps will include City staff review and direction with emphasis on what is in the best interest of our residents and visitors as the primary focus for this Public Park. In addition, there will be an opportunity for public input.
