RE: Health Care Strategies – Findings & Recommendations

During the June 21st City Council Work Session, Mike Jones with Willis Towers Watson will present the City of Columbia Health Care Strategy: Findings and Recommendations. This is follow up to the March 15th presentation regarding the Health Care Strategies Impact on GASB 45 Liabilities overview.

The City conducts an actuarial study every 2 years as required by the Governmental Accounting Standards Board's (GASB) Statement No. 45, on the City's Other Post-Employment Benefits (OPEB). This study calculates the City's liability for postemployment (retiree) health insurance.

The focus of Tuesday's presentation will be to review the results of the projected medical/pharmacy benefit plan cost for Fiscal 2017 (7/1/2016 – 6/30/2017) and to develop premium equivalent rates for Calendar 2017. In addition, The City will also consider the City's Pre-Medicare retiree contributions for purposes of calculating the GASB liability and expense. The presentation will include:

- GASB 45 Actuarial Study Results
- Baseline cost projections for active employees and Pre-Medicare retirees
- Impact on Pre-Medicare contributions based on keeping the current plan design and maintaining the defined dollar benefit (DDB)
- Impact on Pre-Medicare contributions based on plan design changes and maintaining the DDB
- Next steps
