ORDINANCE NO.: 2023-099

*Amending the 1998 Code of Ordinances of the City of Columbia, South Carolina,
Chapter 4, Animals, Article I, In General to add Sec. 4-7, Temporary Use of Livestock for
Clearing Land*

BE IT ORDAINED by the Mayor and Council this _____ day of _____, 2023,
that the 1998 Code of Ordinances of the City of Columbia, South Carolina, Chapter 4, Animals,
Article I, In General is amended to add the following:

Sec. 4-75. Temporary Use of Livestock for Clearing Land.

(a) Notwithstanding the restrictions on livestock as may be found in Chapter 4, a permit to be issued by the City's Planning and Development Department, must be obtained to keep any goats within the City limits for the limited purpose of providing temporary land-clearing services.

(b) No person shall keep any goats for this temporary purpose for longer than seven (7) consecutive days or fourteen (14) total days in any six-month period. The permit shall issue only when in the discretion of the Department the keeping of such an animal in a yard or building under the circumstances as set forth in the application for the permit will not injuriously affect the public health.
